THE ORGANIZATION OF THE FLOWER-FIFTH AVENUE AND THE METROPOLITAN HOSPITALS EMERGENCY SERVICE

In their far-flung war program, the Axis powers have savagely attacked civilian populations within easy range, bringing about reprisals, redoubling the fury of their assaults, and day by day weapons of aerial and submarine attack develop further power and range. Blind faith in the safety of our remoteness from Germany and Japan would be a stupid repetition of the similar folly of other defenseless populations who would not or could not realize their danger. Committed as we are to a fight to a finish, it is our individual duty to provide beyond military preparation for the no less important civilian catastrophies.

Uncertainty may persist as to the unpredictable nature of such attacks, whether by enemy plane or sabotage; but common sense and a decent regard for the lives of all of us demand complete whole hearted cooperation in the service of Civilian Defense which has the responsibility for this important aspect of our war effort. But, here in New York City, incidents and casualties far more than in Warsaw, London, or Coventry involve the factors of density of population, of areas populated by highly unstable and often inherently handicapped nationalities, of crowded congestion, in zones of high buildings which under the impact of high explosives may produce appalling catastrophies.

Our college and its associated hospitals, the Flower and Fifth Avenue and the Metropolitan Hospitals, has had a major responsibility of organizing its resources for the service of Civilian Defense. Instruction has been given to all members of our staff, covering the possible emergency of gas warfare under the able leadership of Dr. Linn J. Boyd as the official representative of the newly organized gas warfare course.

A complete organization has been developed under the splendid leadership of Dr. Edward M. Bernecker, Director of the Emergency Civilian Defense Service of New York City. For the Flower and Fifth Avenue and the Metropolitan Hospitals, a carefully integrated staff, including

has been organized for the efficient management of emergencies both in the first aid and casualty centers as well as in the hospital. Allocation of space is arranged allowing for expansion according to the emergency with reserves of surgical supplies, including casualty equipment, emergency x-ray facilities,

and available reserves of Blood and Plasma.

A manual of Procedures has been prepared by a committee of the Department of Surgery, consisting of the Director and Drs. Kenneth C. Peacock, John Herrlin, Jr., Edward J. McCabe, William P. Eckes, and Walter L. Mersheimer. This manual describes the physical arrangements in both hospitals and outlines the basic pocedures to be followed in the treatment in all emergencies; such as, Shock, Burns, Injuries of the Chest, Head, Eyes, Fractures, etc. The Procedures have been prepared on the basis of the technique followed by the Medical Department of our armed forces, with the experience already gained in dealing with such casualties from English sources and involves fundamental departures in ordinary technique. Copies of this manual may be obtained by application to the office of the Surgical Director, at the Flower-Fifth Avenue Hospital, in Room 842.

Courses in First Aid are being given now to the Freshmen and Sophomore students, supplementing the courses already given to the Junior and Senior classes, and the students are receiving special instruction in clinics and wards in surgical emergencies. They constitute a valuable group to

draw on in the event of any catastrophe.

Through the splendid cooperation of the administrative and nursing Heads of both hospitals, with the fine devotion of the Staff, the Emergency Medical Service in our institutions may, I think, be depended upon to do its part.

THE CHEMICAL WARFARE COURSE AT THE COLLEGE

More than two hundred physicians of New York and environs have received training in the war gases since June, at the College. A few high-

lights from these lectures may merit reproduction.

The important lung irritants are chlorine, chlorpicrin, phosgene and diphosgene. The first two irritate the upper respiratory tract, the last two affect the lower passages. Phosgene, the prototype, has a distinctive odor (Ensilage) and its symptoms ("burn of the lung") culminate in pulmonary edema after a latent period of several hours. These patients are stretcher cases; they require absolute rest; warmth to lessen shock; oxygen for the cyanosis; and venesection for the "blue" cases. The "grey" (collapsed) cases may die if venesection is performed. Digitalis, atropine and the like are useless. Aminophyllin controls the complicating paroxysmal nocturnal dyspnoea. Most deaths (81%) occur within 24 hours; the other fatalities result from virus pneumonia in the next few days. Sequella are rare.

The important vesicants are mustard, lewisite and ethyl-dichlorarsine. Mustard is a "super-poison ivy" evoking symptoms wherever it makes contact and killing only by secondary infection. Lewisite contains 36% arsenic and kills by poisoning; secondary infections do not occur. They are per-

sistent gases (may act for days or weeks) with multiple effects.

Whereas the gas mask protects against the lung irritants and the eye and pulmonary effects of the vesicants, full protective clothing is required

for mustard, lewisite and allies.

Protective creams may act as preventatives. After contact, the lesions may be minimized if dabbed, not rubbed, with strips of cloth from the periphery inward. Anti-gas ointments (chloride of lime or 10% chloramin-T) may be tried. For the arsenicals, 10% H2O2 seems to be the best cutaneous decontaminant.

Blisters produced by mustard do not need to be opened and tend to become secondarily infected. Blisters from the arsenicals must be opened and the healthy skin protected since the contents produce new lesions. If the patient is seen soon after contact, an organic solvent (kerosene, gasoline, etc.) or a thick lather of soap may aid. If any lesion has developed, all treatment suggested is futile and harmful; the therapy is that of a burn. With mustard the sulfonamides may be used to prevent infection and to treat the pneumonia.

The management of eye injuries is the same except that H2O2 is contraindicated. Make the patient open the eye to prove he is not blind; irrigate eyes with 2% sodium bicarbonate or boric acid or water; instill 1% atropine if there is corneal involvement; if necessary use isotonic pontocaine for pain; local anesthetics such as cocaine are contraindicated; bandages and dark glasses should not be used. Oils may prevent synechia.

While block and regional anesthesia have been suggested for those requiring surgery, the use of cyclopropane seems advisable since the anesthetist may control the hypoxia better. Oxygen therapy is also conveniently managed with nasal catheters in lung injuries and in anoxemia.

In addition to the ten members of the College "War Gas Team", six other faculty members are taking the course given by the Army, and will be the "medicos" of six new teams. The first team worked with the E.M.D. and the new teams with the Department of Health.

TUMOR CLINIC THE

The Tumor Clinic will hold its conferences at 11 A.M. on the first Thursday of each month in the Out-Patient Department of the Clinic. At these conferences new patients will be presented for discussion as to diagnosis and therapy. Old cases will be reviewed. Formal presentations will be omitted during the war emergency. The regular clinic hours are each Thursday from 10 to 11 A.M. A Tumor Clinic Fund has been inaugurated to which all fees collected from the radium treatment of clinic and staff patients will be allocated. It is planned that this Tumor Clinic fund will eventually be applied for the purchase of radium for the hospital and also for the use of radon in staff and clinic cases.

STUDENTS: ACTIVITIES

The extra-curricular program of the Medical College and of the Nursing School have been combined, and Miss Helen Louise Baker was appointed in July as Personnel Director of the combined activities. Miss Baker is a graduate of Boston University Sargent College. She was Director of Girls and Women's Recreation in Greenwich House, and Director of group work in Grosvenor Neighborhood House before assuming work in this College.

The Student Government (with the Student Senate as its leader) will take an active interest in solving student problems, lend leadership to student activities and foster a feeling of close cooperation between the faculty and the student body. The Student Government Constitution was ratified by the student body in class meetings and signed by the members of the

Student Senate.

The first college dance was held in the Auditorium on July 31st and members of all classes attended. Students of the College and Nursing School formed a Host Committee and introduced students to each other. A Moonlight Sail was held in August. The party went on the "Americana" up the Hudson River. Patrons and Patronesses on the sail were: Doctor and Mrs. Cope, Miss Lunt, Miss Coatts, Miss Helen Louise Baker and Doctor Leahr.

A Ticket Bureau has been established whereby tickets for theatre, concerts, sports, radio or lecture may be obtained. This has been established in the student lounge and has proved most popular as faculty, students, and interns have availed themselves of the work done in this particular channel. 1669 Broadcast tickets have been obtained and dis-

Plans are going forward for Varsity and Intra-Mural Basketball teams, weight lifting and swimming. Bowling schedules are being planned for games between the faculty and the students.
