A Message From The Dean

HOWARD A. GLICKSTEIN

I am pleased to advise you that the ABA Accreditation Committee has recommended that the Law Center receive full accreditation. The Committee's recommendation has been endorsed by the Council of the Section of Legal Education and will be submitted to the House of Delegates of the American Bar Association at its meeting in Honolulu in August. The recommendations of the Accreditation Committee generally are accepted by the House of Delegates.

We have devoted enormous effort and resources to satisfying the concerns raised by the ABA in recent years, and I hope by now we have done all that was expected of us. Any achievement of the Law Center will inure to the benefit of all our alumni. So for your sakes, as well as for the sakes of all the others who have worked so hard to help us make the progress we have achieved, let us hope that we get good news from the House of Delegates.

Full accreditation, however, will not slow our efforts to move into the ranks of the top law schools. Our next goal is to achieve membership in the Association of American Law Schools. The process for accomplishing this is quite similar to what we have gone through with the ABA. We will need to be inspected by AALS representatives who will pay special attention to the quality of faculty scholarship and to the quality of our library collection. I hope that all we have done to achieve full ABA accreditation will permit us to move through the AALS membership process relatively quickly.

In whatever we do, we need the support of our alumni. Most of you have been anxious to help the Law School in any way you can and I hope this wonderful spirit continues into the future. It is the best hope we have for achieving the high goals of the Law School.



JEFFREY A. WURST ADDRESS TO TOURO GRADUATES

May 21, 1989 • Long Island, New York

I am very pleased to have the opportunity to speak with you today. Just two years ago I stood amongst the graduates of this fine law school. I remember well the mixed feelings I had that day: the desire to relax and enjoy the celebration, yet the feeling of responsibility of what was ahead of me — preparation for and the taking of the bar examination. I realized then what you must realize today, that this celebration, although it is very much an occasion in which we can congratulate you for your accomplishments, is the time in which you get to thank your family and friends for the support they have given you during the past three or four years. Your real celebration will come when you stand before the panel of the Appellate Division of the Supreme Court of the State of New York, and swear to uphold the Constitutions of the United States of America and the State of New York. It was then that I first said to myself, "You've arrived: you're a lawyer. Eureka!"

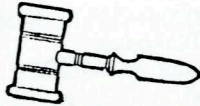

U.S.-CHINA TRADE CONFERENCE

On Sunday, April 9, 1989 the Alumni Association co-sponsored an international conference "U.S. - China Trade: Prospects for the 1990's". Other sponsors were the Transnational Law Journal, the New York State Bar Association/Student Bar Association, International Union, United Auto Workers, and the China United Trading Corporation. The conference was coordinated by Professor Hilary K. Josephs.

The program included four panel discussions following the keynote address delivered by the Hon. Leonard Woodcock. Mr. Woodcock was the first American Ambassador to the Peoples Republic of China and the former President of the United Auto Workers Union. Panel participants included attorneys and businesspeople from both China and the United States. Panel topics included: Business Opportunities and Financing Strategies; Technology Transfer and Legal Protection of Intellectual Property Rights; United States Regulations Imports and Exports with China; and New Developments in China's Tax Laws.

The conference not only furnished valuable information to its participants, but also promoted the Law Center to the international business and legal communities.

The next two months promise to be the worst period of your pledging to join the legal profession. You cannot afford to waste any time. You should allow yourselves only enough rest and recreation to make your study time most effective. Don't give in to any temptation to procrastinate. Remember: the only thing worse than studying for the bar, is studying for the bar again. I wish you luck and strength to see you through these next eight or nine weeks.

Unlike the others who are here today to send you off into the world of legal practice and bid you farewell, I am here to welcome you, welcome you to membership in the Alumni Association of the Jacob D. Fuchsberg Law Center of Touro College. Through your Alumni Association you will not only maintain contacts with your friends and colleagues from law school, you will be part of an ever growing network of professional contacts; contacts that I have learned to rely on in my career.

When I was enrolled in law school I was working full time, supporting a family, and, thus, did not have the time to get involved in student activities. After beginning to practice law, I realized my obligation to give back some of what this fine law school has given to me. That is why I chose to make a commitment to the Alumni Association. The value of our degrees depends on the development of the good name of this law school. That is why every day that we are out in practice, we are ambassadors to Touro. Keep that in mind when you are with others who are less familiar with this school. Let them know how well the Law Center did by you, and you will do well by the Law Center.

This year the Alumni Association has made great strides in its development. We have commenced publication of a quarterly newspaper, have compiled the data necessary for the publication of an alumni directory, which will first be published this fall, and have scheduled a series of regional "networking" receptions, the next of which will be held in Nassau County on July 13th, although you will be busy in preparation for the Bar Exam. Before I conclude, please recall with me the first week of law school - orientation, when we were first introduced to the concept of the syllogism, the basic approach we use as lawyers in reaching a conclusion. You remember, all men are human, Socrates is a man. Therefore, Socrates is human.

I am reminded of the story of the scientist who was performing experiments on laboratory frogs. He took a frog, yelled "jump frog" and the frog jumped six feet. He recorded on his pad that the frog jumped six feet. He then cut off one of the frog's legs and again yelled "jump frog" and the frog jumped four feet. He wrote down "frog with three legs jumps four feet". Then he cut off another leg and again yelled, "jump frog". The frog jumped two feet. He wrote down "frog with two legs jumps two feet". This proceeded until he had cut off all four of the frog's legs, at which time he again yelled "jump frog". The frog didn't jump. He repeated, "jump frog". Still, the frog did not jump. He then picked up his pad and recorded "frog with no legs becomes deaf".

As you become lawyers, remember your training in law school: study the problem and research the issues. Then draw your conclusion based upon the FACTS before you.

Once again, congratulations, and welcome to the ranks of the alumni.

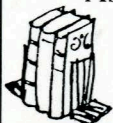

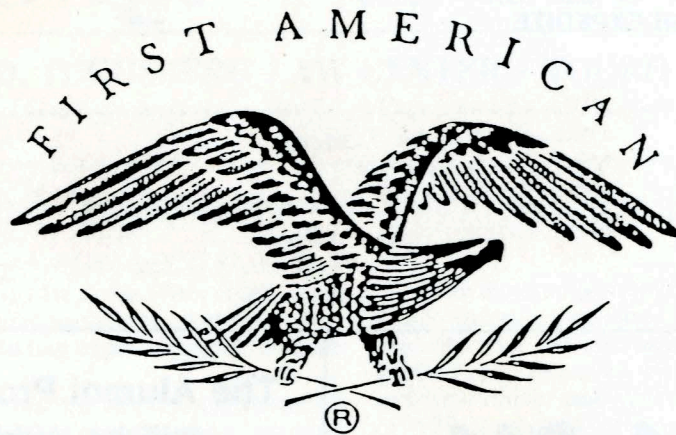

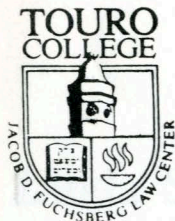
