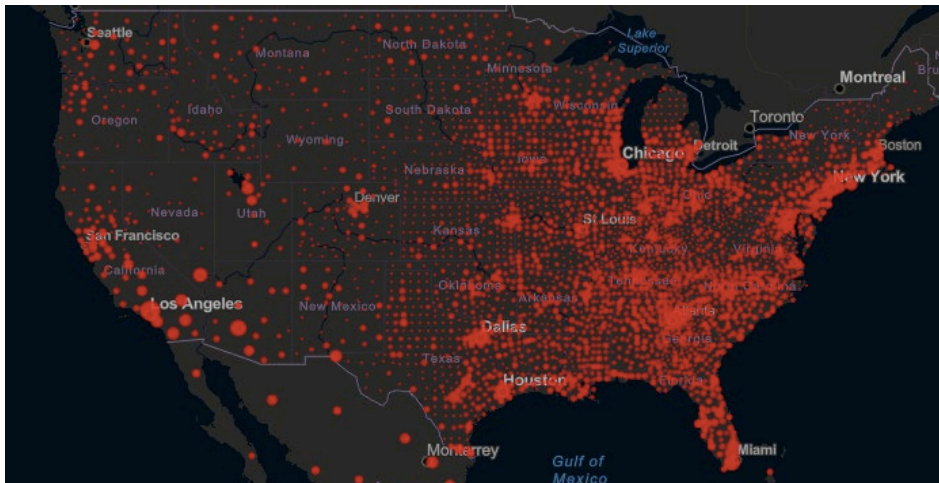

Center for Disaster Medicine Updates

- On June 18, 2021, CDM staff members were invited to speak at an international disaster management conference hosted by the University of Malaga in Spain. The presentation focused on vaccination efforts in New York State.
- On June 10, 2021, CDM staff provided CPR training to NYC hospital police in an effort to maintain overall preparedness.

- Continue to partner with local organizations such as Westchester Department of Emergency Services and Westchester Medical Center to ensure ongoing collaboration with all public safety agencies.

- Updating and developing new programs to provide enhanced education on public health emergencies including pandemics.
- Exploring course development opportunities in infection prevention and control for frontline responders in the hospital and in the field.
- Serving as a source of information for COVID-19 related concerns or questions regarding public health, emergency medical service (EMS), public safety and healthcare response.
- Local networking and pandemic response analysis for New York's tri-state area, using first-person experiences to highlight current trends.

Federal

- The COVID-19 pandemic has been incredibly difficult for all Americans, but even more so for those who lost a loved one to the virus. The unexpected and sometimes sudden loss of a loved one has placed a heavy burden on many thousands of Americans. FEMA is offering help through the establishment of the COVID-19 Funeral Assistance Program. This new program allows eligible funeral expenses to be reimbursed directly to the loved ones who incurred those expenses. Individuals who apply may receive up to \$9,000 per funeral and a maximum of \$35,500 for multiple funerals that occurred within the same state or territory. The sooner people with eligible expenses begin their application, the sooner they can receive their reimbursement. "When people think of FEMA's role in the COVID-19 response, they often think of the work we have done to get shots in arms. That is an important and ongoing mission, but there are other ways we offer support," said FEMA Region 3 Acting Regional Administrator Janice Barlow. "Our hearts go out to those grieving the loss of a loved one to COVID-19. We hope that, through our Funeral Assistance Program, FEMA can help ease some of that burden."

National Institutes of Health (NIH)

NIH study offers new evidence of early SARS-CoV-2 infections in U.S.- A new antibody testing study examining samples originally collected through the National Institutes of Health's All of Us Research Program found evidence of SARS-CoV-2 infections in five states earlier than had initially been reported. These findings were published in the journal Clinical Infectious Diseases.

United States Food and Drug Administration (FDA)

As of June 15, 2021, 384 tests and sample collection devices are authorized by the FDA under emergency use authorizations (EUAs). These include 275 molecular tests and sample collection devices, 81 antibody and other immune response tests and 28 antigen tests. There are 52 molecular authorizations and one antibody authorization that can be used with home-collected samples. There is one molecular prescription at-home test, three antigen prescription at-home tests, five antigen over-the-counter (OTC) at-home tests and two molecular OTC at-home tests. The FDA has authorized 11 antigen tests and three molecular tests for serial screening programs. The FDA has also authorized 534 revisions to EUA authorizations.

CDC provides updated information about the variants in the United States- The emerging variants CDC is closely monitoring have mutations in the virus genome that alter the characteristics and cause the virus to act differently in ways that are significant to public health (e.g., causes more severe disease, spreads more easily between humans, requires different treatments, changes the effectiveness of current vaccines). It's important to understand that genetic mutations are expected, and some variants can spread and become predominant while others subside.

New Medicaid and CHIP Enrollment Snapshot Shows Almost 10 million Americans Enrolled in Coverage During the COVID-19 Public Health Emergency- The Centers for Medicare & Medicaid Services (CMS) released a new Enrollment Trends Snapshot report today showing a record high, over 80 million individuals have health coverage through Medicaid and the Children's Health Insurance Program (CHIP). Nearly 9.9 million individuals, a 13.9% increase, enrolled in coverage between February 2020, the month before the public health emergency (PHE) was declared, and January 2021.

As of June 22, 2021, the FDA has granted Emergency Use Authorization (EUA) to Pfizer BioNTech, Moderna and Janssen/Johnson & Johnson. Now with three vaccines with EUA, the goal is to vaccinate a larger number of persons in the coming months throughout the United States. As additional vaccines are granted EUA, information for those vaccines will also be included.

CDC created this section regarding COVID-19 vaccinations in the United States- CDC provides overall US COVID-19 Vaccine, deliveries and administration, maps, charts, and data updated daily by 8 PM. This section represents all vaccine partners including jurisdictional partner clinics, retail pharmacies, long-term care facilities, Federal Emergency Management Agency and Health Resources and Services Administration partner sites, and federal entity facilities.

Educational Institution Information

- Higher Education
 - About 40 percent of undergraduates experienced a financial disruption due to the COVID-19 pandemic, and 8.2 percent either withdrew (4.4 percent) or took a leave of absence (3.8 percent) from their institution, according to a new report from the National Center for Education Statistics on the ways the pandemic affected undergraduate student finances, housing and enrollment. Over all, 87.5 percent of students reported experiencing a disruption or change in their enrollment due to COVID-19, with 84.1 percent saying that some or all of their classes moved to online-only formats. The report, which NCES says provides “the first national estimates of the COVID-19 pandemic’s impact on postsecondary students,” highlights the disparate experiences of students across racial, gender, economic, institutional and other lines in spring 2020. The report covers the period ending June 30 of last year.

 - As educators close the books on this most unusual and trying school year, many are reflecting on what they did — or should’ve done — to manage their stress, and how they can better self-manage exacting situations going forward. School and district administrators are also acknowledging the importance of staff wellbeing and boosting SEL supports for employees... Teaching was already considered a stressful

job before the pandemic, but research and anecdotal evidence points to a peak during the global health crisis. A survey of hundreds of teachers across the country showed varying degrees of educator anxiety around virtual instruction, communicating with parents, and balancing their school and personal responsibilities, according to research by Tim Pressley, an assistant professor of psychology at Christopher Newport University in Newport News, Virginia. State Updates

New York

- Governor Andrew M. Cuomo announced that with 70 percent of New Yorkers aged 18 or older having received the first dose of their COVID-19 vaccination series, the Empire State Plaza Complex, which includes the New York State Capitol and the Legislative Office Building, will reopen to the public tomorrow, June 18. Additionally, tours of the Capitol resume on Monday, June 21, and the popular outdoor tours of the Empire State Plaza will start up again on Wednesday, July 7. Unvaccinated individuals will continue to be responsible for wearing masks, in accordance with federal CDC guidance. <https://www.governor.ny.gov/news/governor-cuomo-announces-reopening-new-york-state-capitol>
- Governor Cuomo announced that given the statewide progress on vaccinations and the achievement of milestones that allowed the State to lift COVID-19 restrictions, certain State-run mass vaccination sites will begin to downscale and shift their resources for localized vaccination efforts. Over the course of weeks and months, a number of sites will downscale based on demand, proximity to other vaccination sites, and other locally focused efforts. 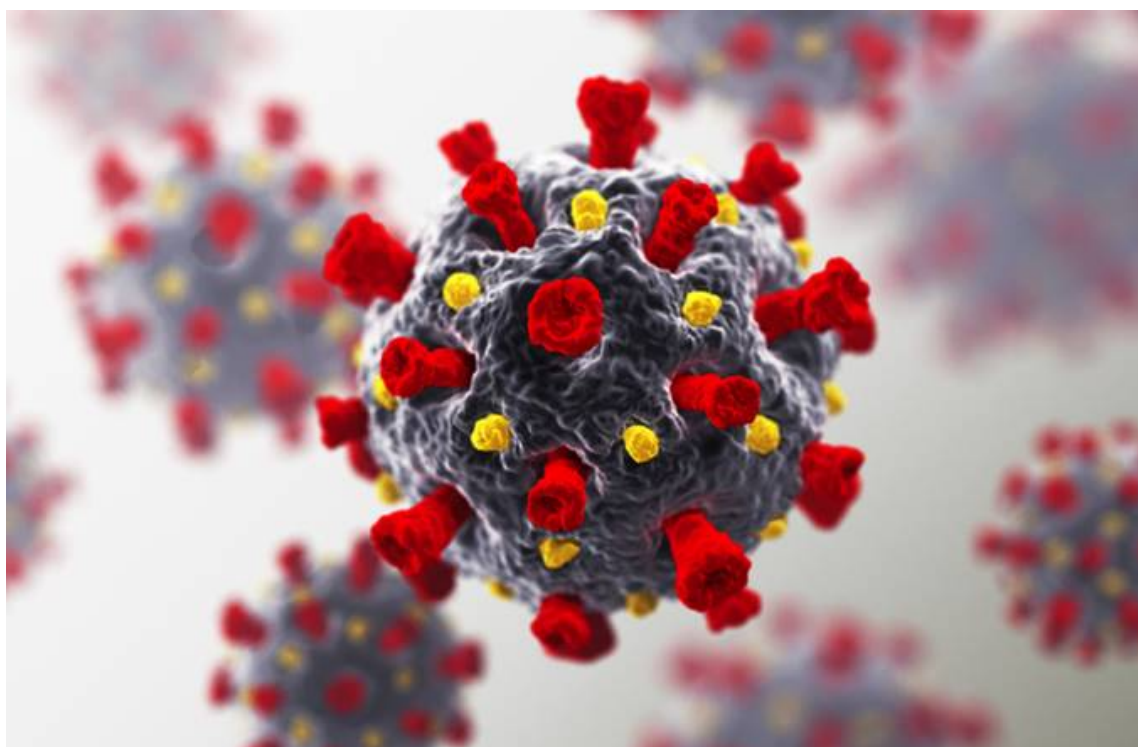

New Jersey

- Building on his commitment to ensuring a high-quality education for all New Jersey students, Governor Phil Murphy signed legislation (S3434/A5366) to offer an additional year of public education and related services to students with disabilities. This bill will provide a temporary one-year extension of special education and related services to students with disabilities who exceed, or will exceed, the current age of eligibility for special education and related services in the 2020-2021, 2021-2022 or 2022-2023 school year following a determination by the student's Individualized Education Program (IEP) team that such education and/or services are necessary. <https://nj.gov/governor/news/news/562021/approved/20210616a.shtml>
- Governor Murphy and the New Jersey CEO Council, a coalition of Chief Executive Officers (CEOs) from some of the state's largest and most widely recognized companies, announced that they are launching the New Jersey Pay It Forward Program. This innovative program will provide interest- and fee-free loans from a revolving fund to support low-income New Jersey career seekers participating in approved training programs. The program in Norwalk is one of 235 statewide that are receiving grants from the State of Connecticut's COVID-19 recovery funds to support expanded educational opportunities this summer. The Connecticut State Department of Education used a portion of its funding from the American Rescue Plan Act's Elementary and Secondary School Emergency Relief Fund to provide the grants.
