# IMPORTANT OUTREACH PROGRAM

Jewish Studies courses produced by the Jewish People's University of the Air, a project of Touro's Herzliah/Jewish Teachers Seminary Division under the direction of DR. JACOB KATZMAN, are being aired with ever increasing frequency in the local area and throughout the country via satellite transmitted by National Public Radio. the tri-state area programs can be heard on Sundays at 1:30 and 7:30 p.m. on WEVD (FM 98) and at 8 p.m. on WNYC (AM 830), and on Connecticut Public Radio on Wednesdays at 1 p.m. More than 30 colleges and universities, many Catholic and Protestant, are using the cassettes either for course work or as a resource for students and faculty, and the cassettes are being acquired by by many installations of the United States Armed Services. Over 60 synagogues, community centers and other institutions are using the cassette courses in youth and adult educational programs. Foreign countries, including Canada, England, Australia, France, Argentina, Brazil and Mexico, have expressed an interest in disseminating the programs.

#### INTERNATIONAL LAW CONFERENCE

Touro College School of Law is hosting the Second International Conference on Jewish Law, sponsored by the Jewish Law Association Dec. 12th through 15th. Daytime sessions will be held at the Civic Center Synagogue, 49 White Street. Two evening sessions will be held at the Women's Division, Central Synagogue, 123 E. 55th Street. Keynote Address will be given at 8 p.m. Sunday (Dec. 12) by Prof. David Daube of the University of California at Berkeley. On Monday at 8 p.m. a panel discussion on "Enforcement of Jewish Divorces in American Law Courts" will be chaired by Prof. Alan M. Dershowitz of Harvard Law School. Panelists are the Hon. Stanley Gartenstein, Supreme Court of the State of New York; Rabbi J. David Bleich, Cardozo School of Law; and Nathan Lewin, Esq., of Miller, Cassidy, Larroca & Lewin. PROF. DOV I. FRIMER, Director of the Law School's Institute of Jewish Law is chairman of the conference. Other Touro faculty presenting papers at the conference are DR. MOSHE SOKOL, Assistant Professor and Chairman of the Philosophy Department, whose paper is entitled "The Taking of Life: Moral Theory and Jewish Sources" and DR. H. JOEL LAKS, an Adjunct in the Philosophy Department, whose topic is "Halakhic Inference and Judicial Interpretation."

Registration for the full conference is \$25 (\$10 for students) and \$10 for one or more sessions any single day.
