LAW SCHOOL EARNS TOP RECOGNITION


Dean Howard A. Glickstein proudly announces that the Association of American Law Schools (AALS) House of Representatives accepted the recom-



mendations of its Accreditation and Executive Committees, and admitted Touro Law Center into membership in the AALS. This landmark achievement was celebrated in a ceremony at the Law Center, Jan. 26.

The AALS is a nearly century old association of law schools, which has as its purpose "the improvement of the legal

profession through legal education." Along with the American Bar Association, whose full accreditation the Law Center received in 1989, the AALS is recognized as one of the two national accrediting agencies for law schools. Shalt Not Harass Thou

Rosie Kahan, Director of Human Resources, reminds us that the College is in compliance with the Equal Employment Opportunity Commission's guidelines on harassment.

Any form of harassment based on race, religion, sexuality, sexual orientation, national origin, handicap, or age will not be tolerated.

Ms. Kahan, recognizing the public's concern with sexual harassment in particular, defined the behavior as "unwelcome sexual advances, requests for sexual favors, and other verbal or physical conduct of a sexual nature." Two kinds of sexual harassment, she said, are recognized:

1. Ouid Pro Ouo: When someone with authority over an employee
