TEL AVIV UNIVERSITY LAW SCHOOL EXCHANGE PROGRAM

We are proud to be conducting a student exchange program in which five Touro students will visit Israel for 10 days beginning in late December. This will be followed by a visit to Touro by five Israeli students. Special meetings will be arranged for Law Center students at Israeli Courts, the Ministry of Justice, and the Knesset. Students will live with Israeli families or law students.

Students who wish to conduct research and attend classes taught in Hebrew or classes in which a fluency in Hebrew is not required, will have the opportunity to do so.

All students interested in this program should speak to Dean Cohen immediately.
