## FROM THE DEAN'S DESK

During the next few weeks, there will be a number of important, exciting events in the Law School. A great deal that is significant in legal education takes place outside of the classroom. You should try to attend as many of these events as possible.

On Wednesday, October 22, at 4:15 pm in the Moot Court Room, we launch a four-part program that we are cosponsoring with the Nassau and Suffolk Bar Associations. The title of the series is "The Practice of Law in the Real World or, Is There Life After Law School?" Leading members of the Suffolk and Nassau Bars will participate in the program including Theodore Hoffman, President-elect of the Nassau Bar Association; Andrew Simon, Dean, Nassau Academy of Law, and Thomas Maligno, Director of the Suffolk County Bar Association. There will be notices throughout the school describing the topic of each of the sessions. Not only do these programs afford a good educational opportunity but they also provide an opportunity to develop contacts with practicing members of the Bar. It is important that the Bar learn of the enthusiasm and intellectual accomplishments of our students. Participating in sessions such as these is one way to accomplish that goal.

On Thursday, October 23, Dean Uriel Reichman of the Tel Aviv University School of Law will visit the Law School. As you know, we are in the process of developing various relationships with Tel Aviv Law School. Dean Reichman will deliver a lecture at 2:00 pm in Room 108. His topic will be the controversy surrounding the recent investigation of the Internal Security Service in Israel.

Other worthwhile events during the week of October 20th are a talk by Judge Leon Lazer of the Appellate Division, Second Department on Tuesday, Oct. 21st and a talk by Congressman Robert Mrazek on Wednesday, Oct. 22nd.

On Tuesday, Oct. 28th, we launch a Distinguished Lecture Series at the Law School. Our speaker is Christopher Sallon, a prominent British barrister. His topic is "The Reform of the British Criminal Trial System." Mr. Sallon will focus on recent developments in Great Britain that undermine the jury system. Mr. Sallon will spend two days at the Law School, will visit classes, and will meet with the Faculty. I urge you to take advantage of this unusual opportunity to meet a leading member of the Bar of another country.

The second session of the Touro/Suffolk/Nassau Bar Program will be presented on Wednesday, Oct. 29th. at 3:15 pm in the Moot Court Room. Andrew Simon, Dean, Nassau Academy of Law and Joel Asarch, Counsel, Nassau Academy of Law will be the speakers.

I repeat what I have said on other occasions; students are short changing their legal education if they do not participate in the many worthwhile activities at the Law School that occur outside of the classroom.

#### TEL AVIV UNIVERSITY LAW SCHOOL EXCHANGE

We are proud to be conducting a student exchange program in which five Touro students will visit Israel for 10 days in late December. This will be followed by a visit to Touro by five Israeli students. Special meetings will be arranged for Law Center students at Israeli courts, the Ministry of Justice, and the Knesset. Students will live with Israeli families or law students.

Any student interested in this program should speak to Dean Cohen as soon as possible. Dean Glickstein and Dean Cohen will meet with students planning to participate in the program on Tuesday, Oct. 21st at 4:30 pm in Dean Glickstein's office.
