FROM THE DEAN'S DESK

The turnout for the Christopher Sallon lecture was impressive. One purpose of events such as that is to provide an occasion for members of the bench and bar to become better acquainted with our school. Nearly a dozen judges attended the lecture and there were a significant number of lawyers as well. Another purpose of bringing to the school persons such as Christopher Sallon is to provide some intellectual excitement for the faculty and student body. I think that Christopher Sallon's visit accomplished that purpose.

Attendance at the programs that we are co-sponsoring with the Nassau and Suffolk Bars has been most disappointing. At the first session of the program, Ted Hoffman, President Elect of the Nassau Bar, was one of the speakers. Barely a handful of students were in attendance. Attendance at the second session was equally as poor. The lawyers from Nassau and Suffolk who have volunteered their services for this program are leaders of the bar and significant opinion makers. They are bound to tell their colleagues how little interest Touro students had in a program designed to familiarize them with the practice of law. This will certainly not open up many employment opportunities for students at Touro. It would help the school's reputation if more of you would take the time to attend.

On Wednesday, November 5th, Judge Bruce Wright of the Supreme Court of the State of New York will speak at the Law School. Judge Wright has been an outspoken critic of the criminal courts, particularly of the bail system. He is a powerful and provocative speaker and I urge you to attend his talk.
