IMPORTANT BAR EXAMINATION MEETING FOR THE CLASS OF '87

On January 12, 1987, Dean Glickstein wishes to meet with every member of the Class of 1987 who will be sitting for a bar examination in July, 1987. The meeting will take place at 4:00 p.m. for day students and 6:15 p.m. for evening students. The meetings will be held in the Moot Court Room (B-2) and attendance is mandatory.

At this meeting the Dean intends to discuss the examination and to provide you with details about a supplementary bar review course that will be offered at the Law Center during the Spring semester. You should be prepared to spend seven Sundays at the school between February 15th and April 5, 1987. The course will give you an opportunity to review the substantive law in several areas and to be examined in these subjects. Additionally, you will have your papers graded by professionals who will assist you in your preparations for the examination. It is imperative that everyone attend this meeting on Monday, January 12th.
