LEXIS TEMPORARY LEARNING CENTER

The Library is pleased to announce that it will be hosting a LEXIS
Temporary Learning Center from March 9 through March 20. LEXIS is a
computer assisted legal research system that allows its users to electronically search the full text of cases, statutes, administrative materials,
and a number of legal periodicals. Cases may also be shepardized on LEXIS.

The purpose of the Temporary Learning Center is to provide an extended opportunity for Touro students, faculty, and staff to obtain hands-on training in the use of this state of the art legal research tool. All upper division students are eligible to attend, as well as, those lst year (and 2nd year part-time) students who have completed and handed in their Moot Court briefs. First year students in particular are strongly encouraged to take advantage of this copportunity. All training sessions will be conducted by library personnel. Five terminals will be available for training, and classes will be limited to ten people. Anyone wishing to sign up may do so at the Library Circulation Desk.
