#### DEAN'S MESSAGE

The ABA inspectors will be at the Law School on Monday and Tuesday, March 23rd and 24th. They will meet with faculty and administrators, attend classes, inspect all aspects of our operation, meet with students at a formal meeting, and informally talk to students. You, of course, are free to say whatever you wish to the ABA inspectors. I only urge that you try to present a balanced picture of what is happening at the Law School.

There will be a general meeting for day students in the auditorium at 4:00 pm on Monday, at which time the ABA inspectors will be available to listen to your comments and answer your questions. At 7:30 pm the inspectors will meet with evening students in the auditorium for a similar discussion. Obviously, a great deal is riding on this inspection; it is a concern to all of us and the right of the right.

I think we have made remarkable progress in a short time and should impress the inspectors with our achievements. Last fall, in order to be certain that we would be ready for this year's inspection, I appointed a committee Chaired by Professor Grant and including Professors Martin Schwartz and Richard Klein. The mission of the Committee was to inventory every criticism that had been made of the Law School by past ABA inspection teams and to establish a plan for meeting everyone of those criticisms. The Committee worked industriously with the faculty and with the administration, and I look forward to demonstrating to the ABA inspectors what we have accomplished.

### NATIONAL APPPELLATE ADVOCACY COMPETITION

The Moot Court Board is proud to announce that they will be hosting and participating in the National Appellate Advocacy Competition, sponsored by the American Bar Association. The participating schools include: Albany, Boston University, Brooklyn, Cornell, New York Law and St. Johns. The issue presented in this Competition focuses on a Probate Court's decision which denied a general guardian of an incompetent, the ability to act as a substitute decision-maker for him in deciding whether a life sustaining treatment in the form of pagogastric artificial feeding shalld be withheld from him. Sharold LeMar and Linda Morrison will represent Touro in this Competition. The judging panels will consist of eminent judges and members of the bar. The Moot Court Board invites the Touro community to observe the Competition which will be held at the Law Center on March 20th, 21st, and 22nd. The arguments will take place on Friday, March 20th from 9:00 am to 4:00 pm; on Saturday, March 21st from 7:30 pm to 9:30 pm and on Sunday, March 22nd from 7:00 pm to 9:00 pm.

#### LEXIS TEMPORARY LEARNING CENTER

The Library continues to host a LEXIS Temporary Learning Center through Friday, March 20th. LEXIS is a computer assisted legal research system that allows its users to electronically search the full text of cases, statutes, administrative materials, and a number of legal periodicals. Cases may also be shepardized on LEXIS.

The purpose of the Temporary Learning Center is to provide an extended opportunity for Touro students, faculty, and staff to obtain hands-on training in the use of this state of the art legal research tool. All upper division students are eligible to attend, as well as, those 1st year (and 2nd year part-time)students who have completed and handed in their Moot Court briefs. First year students in particular are strongly encouraged to take advantage of this opportunity. All training sessions will be conducted by library personnel. Five terminals will be available for training, and classes will be limited to ten people. Anyone wishing to sign up may do so at the Library Circulation Desk.
