FACULTY NEWS

On April 28, 1987, Professor Abramson is submitting legislative testimony to a joint public hearing which will be held by the New York State Assembly's Standing Committee on Governmental Operations, Standing Committee on Commerce, Industry and Economic Development and Standing Committee on Small Business. The Albany hearing concerns the effectiveness of the Office of Business Permits and Regulatory Assistance. Among its responsibilities, the state agency reviews proposed regulations by other agencies.

EXAM ETIQUETTE

When a student is unable to take an examination due to illness, a deferral might be granted if the illness is debilitating to the extent that the student is confined to bed and under the care of a physician. A student will not be excused from an examination if he/she is not under the care of a doctor and does not provide a note from the doctor indicating the nature of the serious/debilitating illness and confirming that it was impossible and inadvisable for the student to take his/her exam as scheduled. The Law Center reserves the right to accept or deny a student's petition to be excused from a scheduled exam.

Stress or stress-related problems are not a valid reason to miss an examination. If a student must miss an exam it is his/her responsibility to (1) telephone the Law Center at least $\frac{1}{2}$ hour prior to the start of the exam; and (2) be examined by a physician prior to or within 24 hours of the scheduled exam; (3) provide the necessary medical documentation to support a rescheduling of the exam. This documentation must be presented to Dean Cohen within one (1) week of the exam.
