FROM THE DEAN'S DESK

I am happy to welcome back our returning students and again greet our new students. I hope you all had an enjoyable and productive summer. Let me mention some of the changes that have taken place over the summer. There have been additions to our regular and adjunct faculty which you will be hearing about at a later time. Our new library space - Rooms 108 and 110 - has been equipped with excellent compact shelving and can accommodate thirty thousand volumes. This should provide enough space to handle the growth of our library for the next two years.

Our cafeteria is under new management and we can look forward to an improvement in the quality of food as well as improvements in the physical arrangement of the cafeteria area. We also are arranging to install air conditioning in the cafeteria.

The school building was in full use all summer. We had a busy summer school program, and bar review classes were held here. Our new class began with an orientation program on August 16th and I am pleased to report that we admitted an extremely well qualified group of about 190 students. I hope that those of you who have been around here for awhile will reach out and help our new students adjust to the rigors of law school.

On Wednesday, August 26th, I will be holding two Dean's Forums — one at 3:15 p.m. and the other at 8:00 p.m. The Forums will be held in the Auditorium. One purpose of these Forums is to permit me to bring you up-to-date on various activities within the Law School, especially our accreditation status. Another purpose is to provide a forum for your questions and comments. I will be happy to entertain any questions you have and try to respond to any of your concerns. I urge all of you to make every effort to attend.

The evening Forum, of necessity, will be short. Because of the schedules of part-time evening students it is difficult to arrange large blocks of time for such events as Dean's Forums or outside speakers. I am, however, prepared to meet with evening students at any time. If a group of you would like to get together with me periodically after your classes at the end of the evening, I would be pleased to be available.

This is the time of year when you should pay special attention to the notices coming out of the Placement Office. The Placement Office cannot send

individual notices or announcements to each student. You must periodically look at the Placement bulletin board. For many employers, the placement season for jobs for the summer of 1988 or for full-time jobs beginning in 1988 will end in October of this year. I know many students who missed out on desirable jobs last year simply because they had failed to apply early enough. The Placement Office is trying quite hard to provide job opportunities for you; it is only you who can take advantage of those opportunities.
