Professor Martin Schwartz and Adjunct Professor Judge George Pratt co-chaired the Practising Law Institute's section 1983 civil rights litigation program. The program will also be presented in November in Los Angeles.

Professor Schwartz also lectured on "Federal Jurisdiction" as part of a continuing education program sponsored by the Suffolk Academy of Law.

Professor Schwartz has been asked to participate in a think session with the Federal Commission on Intergovernmental Relations.

Professor Steven Brock presented a lecture on the right of psychiatric patients to refuse treatment with neuroleptic drugs. The presentation was part of the four day conference of the National Association for Rights Protection and Advocacy at the Renaissance Center in Detroit, Michigan.
