## NATIONAL JEWISH LAW STUDENTS NETWORK

On Wednesday, Nov. 4th at 3:00 pm, Professor Yackov Meron will present a lecture on "The Controversy Over the Interpretation of the Law in Israel." Professor Meron is a Professor of Moslem Law at the Hebrew University Law School in Jerusalem and an official advisor to the Ministry of Justice of the State of Israel.
