NATHAN BURKAN MEMORIAL WRITING COMPETITION

The Nathan Burkan Memorial Writing Competition, sponsored by the American Society of Composers, Authors and Publishers, aims to increase the interest of students in the Law of Copyright and to improve legal writing. A \$500 and a \$200 prize will be awarded to Touro Law Center students who prepare the best two papers on any phase of Copyright Law.
