#### FROM THE DEAN'S DESK

The members of the ABA inspection team are Leigh Taylor, Dean of South-western Law School, Chair; David Thomas, Professor and Librarian, Brigham Young University; Edward Brunet, Professor, Lewis and Clark Law School; Donald Gifford, Professor, University of Florida School of Law and Barry Vickrey, Associate Dean and Associate Professor, North Dakota Law School. Also participating in the inspection will be Dr. Charles Meinert of the New York State Department of Education.

The team members will arrive Sunday night and spend all day Monday and Tuesday at the Law School. The members of the team will visit day and evening classes, meet with faculty members and administrators, inspect our physical facility, meet with members of the Advisory Council, community and bar leaders and alumni representatives, and meet with student leaders. On Wednesday, March 23rd, the team will hold an "exit interview" with Dr. Lander and me and give us some idea of their initial impressions.

In preparation for the visit of the inspection team, we are required to put together a great deal of material for the team's review. All of this material was sent to the members of the team well in advance of their arrival in Huntington. This material provides the team with a comprehensive picture of all activities of the Law School. By the time the members of the team arrive in Huntington, they will know about as much about Touro as anybody else does.

I know you all will join me in welcoming the team to Touro. We have a great deal to be proud of.
