#### FROM THE DEAN'S DESK

I would like to welcome back all of our returning students and use this occasion to welcome once again our new students. I hope you all had enjoyable and productive summers.

There will be a lot more of you around this year than in past Our first-year class is the largest ever. This was not intentionyears. More students accepted our offer of admission than we had anticipatal. There are about 240 students in the first-year class. ed. I understand from faculty members who taught the first-year students during orientation last week, as well as from my own experience, that this group of students is quite a lively bunch. I hope that all of you in the second, third and fourth years will extend yourselves to help our new students adjust to life at Touro.

I regret to report that we did not achieve full ABA accreditation this year. We had every reason to believe that we had overcome all of the ABA concerns and full accreditation would be conferred. The Accre The Accreditation Committee denied our application for full accreditation and we took the relatively unprecedented step of appealing to the Council of the Section of Legal Education. We knew the odds were heavily against us but thought that it would be worthwhile to educate the Council about the developments that have taken place at Touro in the last few years. We were heard by the Council during the ABA Convention in Toronto on August 6th but, unfortunately, we were not successful in our appeal. The remaining obstacle appears to be our bar passage rate. While the Accreditation Committee was pleased with the results on the July 1987 bar examination, the Committee wants to see whether we have established a pattern of good per-Our students studied extremely hard for the July, 1988 bar exformance. am, and I feel confident that the results will be good.

I wish you all a very successful and fulfilling academic year.
