Professor Chaim Povarsky, Director of The Institute of Jewish Law, is pleased to announce that Professor Nahum Rakover, Deputy Attorney-General of Israel will present a lecture entitled "Rights of Privacy and Its Limits in Jewish Law" on Tuesday, Sept. 19, 1989 at 4:00 pm in the Faculty Library.
