

#### 2 NEW DEGREE PROGRAMS IN EDUCATION AND BUSINESS

tarting in September 1998, Touro College will offer two new degree options - a Bachelor of Science in Special Education and a Master of Science in International Business Finance.

The BS Special Education, requiring 120 credits, including 48 credits of professional course work, will prepare students for teaching positions both at the elementary and high school levels. Dr. Gary Lombardo

"The degree and certification requirements provide students with theoretical knowledge and practical skills in this growing field" noted Dr. Harriet Rabinowitz, chairperson of the Department of Education at Touro. Courses for this degree will be scheduled both at Flatbush Campus and at the

mid-Manhattan Campus.

Qualified students are able to complete up to 12 credits applicable to the MA degree programs of the Touro Graduate School of Education and Psychology during their senior year.



The MS in International Business Finance will require 33 credits. Additional prerequisite requirements must be fulfilled by students who completed their baccalaureate studies in a discipline other

than business. The Graduate Admission Management Test (GMAT) is requirement for admission.

The graduate program in business was designed by director Dr. Lombardo, formerly the dean of the Gabelli School of Business at Roger Williams University in Rhode Island.

### FLATBUSH EXPANDS HEALTH SCIENCE OFFERINGS

ouro College has significantly increased its course offerings at the Flatbush Campus for students interested the allied health sciences careers. More than 20 classes in biology, chemistry, and physics have been offered in the Fall and Spring semesters and eight courses are scheduled for the Summer 1998 Semester. The College's laboratory facilities occupy the entire fifth floor of the Flatbush Campus.

Qualified students at the Flatbush Campus, enrolled in preprofessional tracks in occupational and physical therapy and physician assistant studies, are considered for preferential admissions to the highly competitive programs of Touro's School of Health Sciences, leading to M.A. degrees in Occupational or Physical Therapy and the B.S. in Physician Assistant Studies.

The following 13 women students from the Flatbush Campus were recently admitted to the Occupational Therapy Program at the Touro School of Health Sciences: Rivka Cohen, Leah

"We are particularly eager to serve the career interests of Touro undergraduates," notes Dean Joseph Weisberg of the School of Health Sciences.

A full pre-medical/pre-dental sequence is available at the Flatbush Campus. Students in this program have participated in research projects at leading medical centers, including Mount Sinai, Cornell University, Columbia, and Downstate (SUNY).

Highly-experienced, senior faculty teach science courses in Flatbush. They include by Dr. David Lapin, chairperson of the Department of Biology; Dr. Emil Kon, professor of chemistry; Dr. Morris Benjaminson, professor of anatomy at the School of Health Sciences, Dr. Demet Gurel, chairperson of the Department of Chemistry and Physics and Dr. Walton Gutierrez, assistant professor of physics.

Goodman received his bachelor's degree in mathematics in 1984. He went

on to obtain a Master's in computer science. He is the first Touro graduate to complete the series of examinations administered by the Society. Goodman currently resides in Lawrence, New York with his wife Yvette and three children, Tara, Steven and Rachel.

eaving the insulated walls of Touro and entering the work field can be sort of a culture shock. Suddenly you are faced with responsibilities that you were never faced with before. Numerous things can go wrong and the buck stops at your desk. I remember preparing a tax return and asking the secretary to mail it to the client. Only after it was mailed did I realize that I had asked her to send it to the brother of the client I prepared the return for and these two were not on talking terms. Imagine the horror I felt when I realized that the wrong person would be reading confidential information. My first reaction was panic. My second reaction was the feeling of wanting to go home and bury my head under the covers and hope that the mistake would go away. But mistakes don't just go away, and so I took a deep breath and tried to assess the situation rationally. What I decided to do was call the secretary at the receiving end and plead with her to return the envelope unopened, as my job was on

the line. Luckily this story had a happy ending. The important thing to remember is to stay calm, and think rationally in a crisis situation.

Dealing with co-workers is a new experience. In college you can choose who you want to associate or disassociate with. At work, however, this choice is nonexistent. You must learn to get along with the people whom you work with even if you dislike them. It is also advisable not to let your dislikes surface because this can create unnecessary tension among people you have to face every day.

I especially value the personalized attention which I received at the college. My education at Touro enabled me successfully pass the CPA examination. This placed me in a higher earning bracket than women at the firm who were working for a longer time than I, and might be ten or twenty years old than I. I came to realize that these women did not have the opportunity twenty years ago of attending Touro, and so they stagnated in

the work force instead of advancing their careers.

When in the workforce, the accountant comes to realize that the entire profession of accounting is in a state of evolution.



In no area is change more pronounced than in the area of taxation. The accountant who, because she is a college graduate, thinks that she has completed her education is not only naive, but is flagrantly neglectful of her professional responsibility. In order to prepare tax returns competently, it is necessary to continually study changes occurring in the field. There are always new concepts arising from adaptation of current tax law. Keeping abreast of new developments requires year-round attention.
