GREGORY W. CARMAN, CHIEF JUDGE, U.S. COURT OF INTERNATIONAL TRADE DISTINGUISHED JURIST IN RESIDENCE VISIT WEDNESDAY-THURSDAY

The Honorable Gregory W. Carman, Chief Judge of the U.S. Court of International Trade, will be the Law Center's 2000 Distinguished Jurist in Residence, this Wednesday-Thursday, October 25-26. The U.S. Court of International Trade, formerly the U.S. Customs Court, hears civil actions arising out of import transactions and disputes under federal statutes affecting international trade. Judge Carman, a former Long Island Congressman, was appointed to the court by President Reagan in 1983 and became Chief Judge in 1996. He received his B.A. from St. Lawrence University, and his J.D. from St. John's, where he was a member of the law review. Judge Carman will be participating in classes and meeting with faculty, students, and student groups during his two-day stay. The highlight of his visit is expected to be his public lecture, Wednesday, October 25, 6:00 p.m. in the FCR

FAMILY DAY, SUNDAY, NOVEMBER 12, ADDS SPECIAL PROGRAMS FOR 1Ls

On Family Day, this year on Sunday, November 12, continuing students receive awards for academic achievement and school and community service, and family members get an opportunity to tour the school and meet faculty members and administrators. This year, Family Day will have added attractions for first year students. At noon, Professor Ted Silver, a nationally known test preparation expert, will present a session on how to prepare for 1L exams. At the same time, school counselor in residence Jennifer Snow will conduct a workshop exclusively for 1L families, on dealing with the law schoolrelated stress. At 1:00-1:30 p.m., Dean Glickstein will host a reception for 1Ls and their families. Then, regular Family Day events get underway, with school tours at 2:00 p.m., simulated classes for family members at 2:30 p.m., and the awards ceremony and reception at 3:00 p.m.

SPRING 2001 REGISTRATION

A draft Spring 2001 schedule will be posted outside the Office of Student Affairs (Room 121) this week. Students interested in having a course added or a course meeting time changed should circulate or post course petitions on the course petition bulletin board, located to the right of the Registrar's Office. Course petitions should indicate the days and times (day or evening) the course is sought.

Final Spring Semester 2001 Registration materials will be available on Monday, November 6. First year students (day and evening) will register in person in the Auditorium on Thursday, November 16. For all other students, Spring Semester Registration begins Monday, November 13 (3 FT, 4PTD and E) and continues through Tuesday, November 21.

All registration is by telephone (except required courses, which are automatically assigned; clinics, where students must apply and be accepted; and crossover day, Tuesday, November 21, where day students can register for evening electives and evening students can register for day electives. Registration is not on a first come, first served basis. You can register only on the days and times specified in Registration Schedule memo, which will be distributed by the Registrar's Office. To register you must use a touch-tone phone, have a zero balance on your bursarial account, your fall 2000 exam number (available from the Registrar's Office now), your Social Security Number, and a Spring Semester 2001 Registration Packet (for course numbers).

A Course Planning Guide is available from the Office of Student Affairs. Individual course planning advice is available from your faculty advisor, or from the Office of Student Affairs (by appointment please during the registration period - Room 121, x3O5).

FROM THE REGISTRAR

December Grads sitting for NJ Bar. December graduates planning to sit for the February 2001 New Jersey Bar Exam are urged to download the application from the N.J. website: www.njbarexams.org. The date a downloaded application is postmarked determines the fee. There is also a sliding scale for applications requested by phone. Please check your mailbox for detailed information about these procedures.

1Ls Save \$ on Florida Bar: If you plan on taking the Florida bar, you can save money by registering now. Registration within 180 days of starting law school costs \$75. The fee goes up fast after that, from \$100 180-195 days, \$200 196-250 days, \$500 after 250 days. For application forms, contact Florida Board of Bar Examiners, 1891 Eider Court, Tallahassee, FL 32399-1750, (850) 487-1292.

Fall 2000 Test Numbers Available: Fall 2000 Test Numbers are available from the Registrar's Office now. These numbers should be treated as confidential, and must be used on all examinations and papers. To reduce the possibility of loss, the Registrar recommends that you do not pick up your number until you actually need it (e.g., for a mid-term).

TOBACCO WHISTLEBLOWER TO SPEAK

Tobacco industry whistle-blower Dr. Jeffrey Weigand will speak at the Law Center on Wednesday, November 15, 5:30-7:00 p.m. in the FCR. In an interview for a 1996 60 Minutes story, Dr. Weigand blasted the tobacco industry for covering up the dangers of cigarette smoking. 60 Minutes pulled the story after legal threats from Dr. Weigand's former employer, tobacco giant Brown & Williamson, touching off journalistic and scientific controversies.
